

## **PRIVACY STATEMENT**

At MyVideoTalk, we take the information you share with us very seriously. MyVideoTalk is the sole owner of the information collected on our Sites. We will not sell, share, or rent this information to others in ways different from what is disclosed in this Policy (including as it may be amended—see below).

### **Your Acceptance of These Terms**

Your continued use of MyVideoTalk products, services and websites signifies your consent to the MyVideoTalk Privacy Policy. This policy is reviewed periodically by MyVideoTalk management and may be subject to change.

### **Information Gathered and Tracked**

We collect information about you when you visit and use the Site, and particularly when you enter or input information, whether during the course of entering, initiating, fulfilling and transmitting information or otherwise in connection with your general activities and/or use of the Site. You may however, use this site without disclosing any personal information about yourself.

If you are submitting personally identifiable information on behalf of others in your business for registration purposes or otherwise, you represent that you have their permission, agreement and full authorization to provide this information to us for these purposes. If we determine that such authorization has not been properly obtained, we may immediately and without notice, discontinue your authorized use of those features of the Site for which you have registered.

MyVideoTalk uses cookies. This improves the convenience and efficiency of your experience when using our products and services. A cookie is data stored on the user's hard drive which links to statistical information about the user. Usage of a cookie is in no way linked to any personally identifiable information

### **How Does MyVideoTalk Use My Information**

In the purchase process you are required to provide contact information (such as name, shipping address, phone number, and email address) . We use this information to communicate with you about your account, to notify you about important functionality changes to the web site, new services, and special offers we think you'll find valuable, company emails and newsletters. If we have trouble processing an order, we use this contact information to get in touch with you. Demographic information provided at time of purchase process may also be given to the selling representative to assure quality customer care.

We may disclose aggregated information about our members but that information contains no personal information. In some situations, we share personal information with third parties who provide support for the internal operations or enhancement of the services. Due to the existing regulatory environment,

we cannot ensure that all of your private communications and other personal information will never be disclosed in ways not otherwise described in this Privacy Policy.

By way of example (without limiting the foregoing), we may be forced to disclose personal information to the government or third parties under certain circumstances, or third parties may unlawfully intercept or access transmissions or private communications. We can (and you can authorize us to) disclose any personal information about you to law enforcement or other government officials as we, in our sole discretion, believe necessary or appropriate, in connection with an investigation of fraud, intellectual property infringements, or other activity that is illegal or may expose us to legal liability.

### **Security**

We make every effort to prevent the loss, misuse, and alteration of our users information under our control. In addition, we, and our partners, always use a secure connection when collecting personal financial information from you. However, no data transmission over the Internet can be guaranteed to be 100% secure.

If MyVideoTalk receives any type of financial lien (including IRS tax lien, court lien, etc.) on your account, your account will be cancelled until proven that the lien has been paid off. Upon receiving such lien a copy is immediately sent to the tax payer and all directions given by the court, IRS, etc. will be followed promptly. We must receive a Termination of Order to Withhold form in order to bring your account back to good standing.
