

MVT Product Terms & Conditions

Please read this agreement carefully. To complete your order for MyVideoTalk Products & Services, you (User) must first read and accept the Terms of Service. Submission of your order constitutes acceptance of the Terms of Service which may be updated by us from time to time without notice to User.
